Notes About Our Methodology

Rankings

- For all measures, a rank of 1 is the highest value of the metric among the 95 counties and 95 is the lowest. Due to data availability, only 91 counties are ranked for overdose deaths, 89 counties for suicide deaths, and 79 counties for low birthweight births.
- When counties have the same value, they share the same ranking, which affects subsequent rankings. For example, 100% of individuals in 32 counties live in a rural area. All 32 counties are ranked as 1, and the county with the next highest rural concentration (99.9%) is ranked 33.

Measure Selection Criteria

• To be included, all measures had to be available at the county level and supported by the literature on the drivers of health.

Timeliness of Data

- We used the most recent county-level data available at the time of publication for each metric. However, the year of the most recent data varies by each source.
- To provide context for the county-level data, the state- and national-level data shown represent the same year(s) as the county data. In some cases, the comparable state- and national-level data may not represent the most recent available data. For example, some of the economic measures use 5-year estimates that represent an average over 2019-2023. These are the most recent estimates available across all counties; however, 1-year estimates that represent 2024 are available at the state and national levels but are not shown here because they would not be comparable to the county-level data.
- National-level data comparable to state- and county-level data were not available for all metrics shown.

The Drivers of Health

Research shows there are non-genetic, non-medical factors that influence our health. We call these influencing factors the drivers of health, but they are often referred to as the social determinants of health. (6) (7) (8) They include:

- **Economic stability** Reliable income and resources to meet basic living expenses and financial needs.
- **Neighborhood and built environment** The physical characteristics and infrastructure of a community that influence safety, housing, transportation, and the environment.
- **Education access and quality** The availability of and quality of educational opportunities that support learning and skill development across all life stages.
- **Social and community context** The relationships, social networks, and community structures that shape individual and collective well-being.
- Clinical care access and quality The availability and quality of medical services that support prevention, treatment, and overall health.
- Health behaviors The personal actions and lifestyle choices that affect physical and mental health outcomes.

Fair/Poor Health: percent of adults who rate their health as "fair" or "poor" (age-adjusted rate)

Most national data sources measure voter turnout as a percent of the voting-eligible population—estimates for which were not readily available at the county-level. Meanwhile, national data sources that included the number of registered voters reported numbers for Tennessee that conflicted with the Secretary of State's data.

Violent Crime Rate: number of violent crimes committed per 1,000 population
